



## Eligibility Criteria for a BC Wood Member

To register as a BC Wood Member and receive cost-shared marketing services, your firm must meet the following criteria:

- ◆ Your firm must have been in business for six months
- ◆ Your firm must have a WCB number
- ◆ Your firm must produce value-added wood products and those products must constitute at least 60% of the firm's business.
- ◆ Your value-added wood product must be made of at least 1/3 wood
- ◆ Your firm must manufacture at least 60% of its value-added wood product in British Columbia

Notes:

1. The definition of "firm" includes a BC-based division of an out-of-province company.
2. If a firm does not meet the eligibility criteria, it may become an "Associate Member". For information, please contact BC Wood.
